

# Video Editing Terms & Conditions

Fahad Creative Studio

## 1. Scope of Services

Fahad Creative Studio provides video editing services including cutting, transitions, color grading, sound design, subtitles, and motion graphics as agreed in the project brief. Any work outside the agreed scope will be charged additionally.

## 2. Project Workflow

Projects are divided into stages:

- Reference Review
- Raw footage review
- First draft delivery
- Revisions
- Final delivery

Each stage requires client feedback before proceeding.

## 3. Payment Terms

- A minimum 60% upfront payment is required before work begins.
- Final delivery will only be provided after 40% remaining payment.
- All payments are non-refundable once editing has started.

## 4. Revisions Policy

- A limited number of revisions are included per plan.
- Additional revisions will be charged separately.
- Major changes (new concept, structure, or storyline) will be treated as a new project.

👉 Clear revision limits prevent scope creep and disputes

## 5. Turnaround Time

- Timelines are agreed before the project starts.
- Delays caused by late feedback or missing assets from the client will extend deadlines.

## 6. Client Responsibilities

- Clients must provide all footage, assets, and instructions on time.
- Client confirms they have full rights to all provided content.
- Client is responsible for reviewing and approving all drafts.

## 7. Copyright & Ownership

- Final edited video ownership is transferred after full payment.
- Raw files and project files remain property of Fahad Creative Studio unless agreed otherwise.
- Fahad Creative Studio reserves the right to use work for portfolio and marketing.

## 8. Raw Footage Policy

- Raw/unedited footage is not included unless specified.
- If requested, additional charges will apply.

## 9. File Delivery

- Final videos will be delivered in agreed formats (e.g., MP4, 720p/1080p/4K).
- Source/editable files (Premiere Pro, After Effects, etc.) are not included unless specified.

## 10. Third-Party Assets

- Music, fonts, and stock footage may require licensing.
- Client is responsible for purchasing licenses if needed.

## 11. Cancellation Policy

- Before work starts: eligible for refund.
- After work starts: no refund or partial refund.
- After final delivery: no refunds.

## 12. Liability Limitation

- Fahad Creative Studio is not liable for any business losses, revenue loss, or damages resulting from video use.
- Liability is limited to the amount paid for the project.

## 13. Confidentiality

All client materials and project details will be kept confidential and not shared without permission.

## 14. Approval & Final Responsibility

- Once approved, Fahad Creative Studio is not responsible for errors (e.g., text, audio, timing).
- Client must review content carefully before final approval.

## 15. Data Storage

- Project files may be deleted after a specific period (e.g., 15–30 days).
- Clients are responsible for backing up delivered files.

## 16. Termination

Either party may terminate the project with written notice. Client must pay for all completed work up to termination.

## 17. Amendments
