1. Scope of Work & Deliverables

- **Services Provided:** We offer video editing, beat-syncing, color grading, sound design, and visual effects for short-form content (TikTok, Instagram Reels, YouTube Shorts).
- **Production Workflow:** To ensure fast turnarounds and high retention, edits are built using proven, battle-tested editing frameworks, viral templates, and FX presets. Every project is individually assembled with custom frame-matching, beat-syncing, and color adjustments tailored specifically to your provided media.
- **Source Material:** Clients must provide all necessary raw video footage, audio choices, or reference clips required to complete the edit.
- **Format:** Final edits will be delivered as digital MP4 files (optimized for 9:16 vertical short-form platforms) via secure cloud link (Dropbox/Google Drive).

2. Payment Terms

- **Advance Payment:** A **60% advance payment** is required before editing begins.
- **Final Delivery:** The remaining **40% balance** is due upon final project approval and before watermark removal / final high-res file delivery.
- **Subscription / Retainers:** Monthly batch packs require full upfront payment or an agreed recurring billing cycle at the start of each service period.

3. Turnaround Times & Delivery

- Standard turnaround times (24–72) hours for individual edits; 5–7 days for batch packs) begin only after **all raw assets, audio selections, and required project briefs** are fully received.
- Delays in client feedback, missing assets, or scope changes will pause the delivery timeline.

4. Revisions & Approvals

- Each project includes the specified number of free revisions outlined in your chosen package.
- Revisions cover minor tweaks (e.g., timing adjustments, text fixes, color tweak).

- **Out-of-Scope Changes:** Complete changes in chosen audio tracks, requests for a totally different editing style, or submitting brand-new source footage midway through a project are considered new orders or subject to extra fees.
- Additional revisions beyond the package limit incur a **+\$2 fee per revision pass**.

5. Copyright & Media Usage Rights

- **Client Assets:** The client confirms they possess all necessary rights, licenses, or permissions for any copyrighted footage, music, or media provided to us.
- **Final Content Rights:** Upon full settlement of payment, the client receives full commercial rights to use and distribute the final edited video.
- **Portfolio Usage:** Fahad Creative Studio reserves the right to display completed edits in our portfolio, website showcases, and social channels for promotional purposes unless a non-disclosure agreement (NDA) is explicitly requested and signed prior to production.

6. Refunds & Cancellations

- **Pre-Production:** A full refund of the deposit is available if you cancel before editing work has commenced.
- **In-Production:** Once editing or FX work has begun, the 60% advance deposit is **non-refundable** to cover dedicated labor and production time.
- **Final Files:** Due to the custom nature of video editing, no refunds are issued after final water-mark free files have been delivered.
